**Bananas Foster, Inc. Form 990 Tax Return for Year Ended December 31, 2024**

The mission of Bananas Foster is to celebrate the foster care community, while educating and inspiring others to get involved.

Following a thorough review of supporting documentation and to reflect the organization's commitment to transparency and accurate financial disclosure, amendments to Form 990 were made. These amendments provide a more precise representation of the organization's financial activities and public support and do not affect the organization's exempt status or mission.

Corrected items primarily include, but are not limited to, the following:

- Part VIII, Lines 1H and 2G, program service revenues originally reported on line 2G were reclassified as contributions and grants under Line 1H.
  - This reclassification increased the total reported contributions and impacted the public support percentage calculation on Schedule A, Part II.
- Adjustments were also made to Part IX, Lines 1 to 25, where total expenses were reduced due to the removal of in-kind service expenses.
  - This correction is reflected in Part III, Line 4A, specifically under the "Go Bananas for GameDay" program and is further detailed in Schedule I, Part III, Columns (B)(F).
- Additionally, Part VII, Section A, was revised to correctly state the positions of each listed person and remove the person that did not meet any reporting thresholds per the Form 990 instructions.

All donations are used to support the organization's mission and those in the foster care community. This amended filing reflects Bananas Foster's continued dedication to accountability and excellence in stewardship.

The 2024 data reflect the first full year of operations for Bananas Foster and the first year celebrating the foster care community. As the organization continues to grow, more families will be supported through the mission and inspired to get involved.

Bananas Foster remains deeply grateful for the generosity and trust of its supporters. With continued transparency and integrity guiding every step, the organization looks forward to expanding its impact—celebrating more families/individuals making a difference in the foster care community, educating society, and inspiring more people to create a lasting change for children and teens experiencing foster care.
